HEREBY STATES

To be aware that:

- to reproduce a cultural object the fees set out in the Cultural Heritage Government Office price list shall be paid;
- to reproduce a cultural object for strictly personal use or for study purposes the costs incurred into by the Administration Office only shall be reimbursed;
- for any other use the dues provided for in the Law dated January 14 1993, n° 4 and in the Ministerial Decree dated April 8, 1994 shall be paid; any other use shall be authorised upon additional application;
- any other use other than the one stated herein will not be lawful without written authorisation by the Administration office;
- shots with actors or bit players in fancy dress are not authorized.

UNDERTAKES

- not to disseminate or sell to the public the reproduction obtained. Non compliance with this obligation implies exclusion from the access to the State Cultural Institutes (Monuments and Fine Arts Services, museums, archives, libraries) as well as the enforcement of the penalties provided for in the relevant laws:
- to submit to the Administration Office three (3) copies of the original
- to specify at the foot of the images, the sources of the reproduction and the subjects authorised; additionally, at the foot of the images the sentence "upon authorisation of the Ministry for Cultural Heritage and Environment" shall be written as well as the notice specifying that reproduction or duplication by any means is forbidden

The Minister for Cultural Heritage and Environment shall be held harmless against any damages which may be suffered by objects or persons during the shooting operations performed inside of the State Institutes where cultural objects are located.

Based upon:

- what required and stated and based upon the applicant's commitment;
- the payment of the fixed fee of € 2.065,83 for day, in compliance with the Law dated January 14 1993, n° 4 and with the Ministerial decree of April 8, 1994;
- the payment of the caution money of € 6.197,48.

It is hereby specified that:

The fee includes reproduction rights for one edition in one language or for one broadcast in one television network only With respect to additional broadcasts the following shall apply:

- for two broadcasts on the same TV network or heading an additional 25% (€ 2.582,29)
- for more than two broadcasts on the same TV network or heading an additional 75% (€ 3.615,20)
- for several TV broadcasts, as it happen with broadcasts by sat, for the same programme, in one language and during a year, the fee increase by 75% (that is € 3.615,20 for every day of shooting);

- the world rights are three times the fees (that is € 6.197,48 for every day of shooting. We specify that the conditions in force don't provide the perpetual assignment for reproduction rights, that are granted each time for a specific period or for a specific initiative (note prot. n.799 of January the 19th 2001 by the Ufficio Servizi Aggiuntivi of Ministero per i Beni e le Attività Culturali in Rome). For further uses or for uses other than photo, cinema and television shooting (derivative audio-visual products) in addition to the tariffs and duties above, 12% royalties on the gross income generated by any additional and different use of the photographed, filmed or videotaped material shall be paid.
