#### **HEREBY STATES**

To be aware that:

- to reproduce a cultural object the fees set out in the Cultural Heritage Government Office price list shall be paid;
- to reproduce a cultural object for strictly personal use or for study purposes the costs incurred into by the Administration Office only shall be reimbursed;
- for any other use the dues provided for in the Law dated January 14 1993, n° 4 and in the Ministerial Decree dated April 8, 1994 shall be paid; any other use shall be authorised upon additional application;
- the concession, which cannot be transferred to third parties, shall not be exclusive and shall be issued only once.
- Any other use other than the one stated herein will not be lawful without written authorisation by the Administration office.
- exemption from reproduction duties is provided for publishers who publish scientific magazines or books with a total circulation lower than 2.000 copies and with a cover price lower than € 77,47 (both the last two requirements have to be met);
- printings made at the premises of the same publisher can get a 50% reduction of the tariffs set out for the reproduction duties in force when the publication is issued:
- international duties correspond to three times as much the tariffs for the reproduction duties in force when the publication is issued;
- the re-use of the matrix implies:

a) if re-used by the same publisher for another publication: 10% reduction of the tariffs for the reproduction duties in force when the new publication is issued:

b) if re-used by another publisher; 25% reduction of the tariffs for the reproduction duties in force when the new publication is issued

#### **UNDERTAKES**

- to submit to the Administration Office copy of the scientific work and of the reproductions;
  - to specify at the foot of the images, the sources of the reproduction and the subjects authorised;
- additionally, at the foot of the images the sentence "upon authorisation of the Ministry for Cultural Heritage and Environment" shall be written as well as the notice specifying that reproduction or duplication by any means is forbidden
